

RESOLUTION FY 2020-6

Contract to Provide Behavioral Health Services in the Fostoria City School System between Fostoria City Schools, Hancock County Board of Alcohol, Drug Addiction and Mental Health Services, Wood County Board of Alcohol, Drug Addiction and Mental Health Services, the Mental Health and Recovery Services Board of Seneca, Sandusky and Wyandot Counties, and Family Resource Centers (Provider).

WHEREAS, Fostoria City School District encompasses multiple counties; and

WHEREAS, The Boards are responsible for planning, contracting, funding, auditing and evaluating mental health and alcohol and drug addiction treatment services for the residents of the city of Fostoria in accordance with Ohio law; and

WHEREAS, the Provider is an Ohio corporation with the purpose, among others, of providing mental health and substance abuse services to children and their families, and is administered by its own Board of Trustees; and

WHEREAS, the Provider is certified or deemed by the Ohio Department of Mental Health and Addiction Services (“ODMHAS”) and it qualified to provide the behavioral health services described in this contract; and

WHEREAS, the Schools and the Boards are committed to enhancing the integration of, and improving access to behavioral healthcare services for children and adolescents in their local community and natural environment with the purpose of building a continuum of supports and services to address non-academic barriers to learning; and

WHEREAS, the term of this agreement will commence on July 1, 2019 and will terminate on June 30, 2020. The Wood County Alcohol Drug Addiction, and Mental Health Services Board agrees to pay Provider up to \$5,714.00; and


Whereas, the Board has allocated sufficient local levy funds for this contract.
