Arrowhead Behavioral Healthcare FY 2017 Contract Amendment

March 27, 2017

Whereas, the Wood County Alcohol, Drug Addiction and Mental Health Services Board (Board) approved a contract with Arrowhead Behavioral Healthcare resolution #FY2016-73 on June 27, 2016 to provide inpatient psychiatric and sub-acute detoxification services, and


Whereas, Arrowhead has provided needed services for which the cost has exceeded the contract amount, and

Whereas, the Board wishes to compensate Arrowhead for the provision of such needed services, and there are sufficient funds in the Boards FY 17 bed day line item to cover this amount.

Therefore, the Board authorizes to increase the contract limit by \$75,000 for a total revised contract amount of \$150,000 for FY 2017, and that there are no modifications to the term of this Agreement that will be valid through the 30th of June, 2017.

Randy Rothenbuhler made the motion and John Alexander seconded. A roll call vote was called on the question of its adoption. Motion passed.

AMENDMENT

THIS AMENDMENT, is made and entered into this 27th day of March, 2017 by and between the Wood County Alcohol, Drug Addiction and Mental Health Services Board, hereinafter referred to as the "Board" located at 745 Haskins Road, Bowling Green, Ohio 43402 and Arrowhead Behavioral Health, located at 1725 Timber Line Road, Maumee, Ohio 43537, hereinafter referred to as "Provider".

WHEREAS, the Board and the Provider entered into a provider contract for inpatient adult psychiatric and drug and alcohol detoxification treatment, effective July 1, 2016 and expiring June 30, 2017 (hereinafter the "Original Contract"); and

WHEREAS, the Original Contract provides that the Agreement may be amended or modified by the mutual agreement of the parties hereto in writing to be attached to and incorporated into the Agreement; and

WHEREAS, the Board and the Provider agreed to reserve the right to amend the Original Contract for additional dollars as needed to meet increased demand for services;

WHEREAS, the Board and the Provider desire to amend the Original Contract to include additional funding to meet the increased demand for services; and

WHEREAS, the Board and Provider agree that all other terms of the Agreement shall remain unchanged.

NOW THEREFORE, the parties hereto, each in consideration of mutual promises and obligations assumed herein by the other, agree as follows:

WITNESSETH:

1. The parties agree that the last sentence in Section "4. Compensation" of the Original Contract shall be amended to increase by \$75,000 the total amount payable under the contract:
 4. Compensation. * * * The maximum paid to PROVIDER under the terms of this agreement shall be \$150,000.00
2. The parties further agree that all other terms and conditions of the Original Contract shall remain unchanged.
